In continuation to this Office Notice No.725/PSC, dated 02.02.2017, it is impressed upon all the 1740 candidates, who have been provisionally qualified for admission to Odisha Civil Services Main Examination 2016, pursuant to Advertisement No. 01 of 2016-17 that they are required to submit the printout/hard copy of online application form indicating Roll No. along with original fee challan and **photo copies of self attested other documents** as stated in para-14 of the Advt., to the office of the Commission by Regd. Post or Speed Post, which should reach **on or before 4.5.2017** positively, failing which their candidature will be summarily rejected. **The Commission will not take any responsibility if the printout/hard copy of the online application form along with all the required certificates/documents is not received in time.**

It is also made clear that, the candidature of these candidates for this recruitment is **purely provisional** and subject to fulfilment of Terms and Conditions laid down in the Advertisement. The candidature is liable to rejection in the event of inadequacy/deficiency found at any stage.

The candidates are also required to bring all the **Original Documents** for verification on the day of Personality Test.

List of Documents to be furnished in the following order.

1. Original fee challan towards deposit of Examination Fee of Rs.300/-, wherever applicable.
2. H.S.C or Equivalent Certificate in support of Declaration of Age.
3. Intermediate/+2 Examination Certificate.
4. Bachelor's Degree Certificate along with the mark sheets of each Semester/Year.
5. Required Odia Pass Certificate.
6. Addhaar Card
7. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).
8. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by Birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.
9. A declaration regarding number of attempts exercised by the candidates in the OCS Examination.
10. In case of Sports Person Candidates:- Identity Card issued by Director of Sports, Odisha.
11. In case of PWD candidates:- Permanent Disability Certificate (Indicating % of disability) issued by concerned Medical Board, wherever applicable.
12. In case of Ex-Servicemen candidates:- Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board. The Ex-servicemen candidates must be discharged on or before 04.01.2017.
