2. H.S.C. or Equivalent Certificate in support of Declaration of Age.

4. B.Tech./B.E. Degree Certificate issued by the recognized University.
5. Mark-sheets in support of all the aforesaid Examination (i.e. H.S.C. to B.Tech./B.E. Degree) passed including fail marks, if any issued by the concerned Board/Council/University.
6. Required Odia Pass Certificate.
7. Aadhaar Card in original and its photocopy duly attested by the candidate.
8. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).
9. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.
10. In case of Sports Person candidates: Identity card issued by Director of Sports, Odisha.
11. In case of PWD candidates: Disability Certificate (Indicating % of disability) issued by concerned Medical Board.
12. In case of Ex-Servicemen candidates : Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board in original.
