4. B.A. Degree/+3 Arts (**English** Stream) Certificate issued by the recognized University;
5. Master's Degree certificate issued from the recognized University in concerned subjects **with proof of securing at least 50% marks in aggregate**;
6. Mark-sheets in support of all the aforesaid examinations (i.e. H.S.C. to Master's Degree and B.Ed.) passed including fail marks, if any, issued by the concerned Board/Council/University;
7. B.Ed. or equivalent Degree recognized by the National Council for Teacher Education, New Delhi as equivalent with B.Ed. from recognized University;
