1. Attestation Form & Bio-data duly filled in (To be downloaded from the website of the Commission).
2. H.S.C. or Equivalent Certificate in support of Declaration of Age issued by the concerned Board/Council.
3. Intermediate/+2 Examination Certificate or equivalent Certificate issued by the concerned Board/Council.
4. Bachelor's Degree Certificate from recognized University.
5. Master Degree Certificate issued by the Recognized University.
6. Mark list in support of all aforesaid Examinations passed (i.e. HSC to Master's Degree) including fail marks if any issued by the concerned Board/Council/University.
7. Conduct Certificate.
5. Required Odia Pass Certificate in Odia language in ME School Standard or HSC examination.
6. Aadhaar Card in original and it's photocopy duly attested by the candidate.

7. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).
8. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.
9. In case of Sports Person candidates: Identity card issued by Director of Sports, Odisha.
10. In case of Ex-Servicemen candidates : Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board in original.
11. The Ex-Servicemen candidates are required to furnish an Affidavit in original indicating that-

“I have not got any appointment as an Ex-Serviceman against Civil Post against the Quota available for the said category”.

**OR**

Certificate in Original issued by the Employer/Controlling Authority showing the Date of Joining in the Civil Post/Service in the Government Job on the civil side availing the Ex-Servicemen benefit.

**OR**

An Affidavit in Original showing the Date of Joining in the service availing Ex-Servicemen benefit.
