It is for information of all concerned that the V.V. Test, for recruitment to the posts of Assistant Conservator of Forest, (Advt. No.14 of 2015-16), special recruitment of Forest Ranger (Advt. No.20 of 2015-16) and recruitment of Forest Ranger (Advt.No.21 of 2015-16) will be held from 30.08.2017 onwards. Details of the schedule of the V.V. Test will be notified shortly.

The candidates are required to come with hard copies of online application form (indicating their **Roll Nos.** at the top right corner), self-attested copies of all relevant certificates, documents etc. as mentioned in the Advertisement and duly filled in "**Attestation Form**" & "**Bio-data Form**" (to be downloaded from the website) and submit the same **in person** on the day of V.V. Test.

It is also made clear that, the candidature of these candidates for this recruitment is **purely provisional** and subject to fulfilment of Terms and Conditions as laid down in the Advertisement. The candidature is liable for rejection in the event of inadequacy/deficiency if found at any stage before or after the V.V. Test.

The Intimation Letter of the candidates concerned and "Attestation Form" & "Bio-data Form" are available in the website. The candidates are required to download their "Intimation Letter" and "Attestation Form" & "Bio-data Form" from the website of the Commission at <http://opsc.gov.in> and produce the same for admission to V.V. Test.

The candidates are also required to bring all the **Original Documents** for verification on the day of Personality Test.

List of original Documents to be furnished in the following order.

1. "Attestation Form" & "Bio-data Form" duly filled-in (To be downloaded from the website of the Commission)
2. H.S.C or Equivalent Certificate in support of Declaration of Age.
3. Intermediate/+2 Examination Certificate.
4. Bachelor's Degree Certificate along with the mark sheets of each Semester/Year.
5. Required Odia Pass Certificate.
6. Aadhaar Card in original and it's photocopy duly attested by the candidate.
7. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).
8. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.

9. In case of Sport Person Candidates:- Identity card issued by Director of Sports, Odisha.
10. In case of Ex-Servicemen candidates:- Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board in original.
11. The Ex-Servicemen candidates are also required to furnish an Affidavit in original indicating that,
"I have not got any appointment as an Ex-Serviceman against Civil Post against the Quota available for the said category".
OR
Certificate in Original issued by the Employer/Controlling Authority showing the Date of Joining in the Civil Post/Service in the Government Job on the civil side availing the Ex-Servicemen benefit.
OR
An Affidavit in Original showing the Date of Joining in the service availing Ex-Servicemen benefit.
