On the basis of Odisha Judicial Service Preliminary Written Examination-2015, held on 06.09.2015, 752 candidates (list enclosed) have been **provisionally** qualified for admission to the Odisha Judicial Service Main Written Examination, 2015 pursuant to Advertisement No. 07 of 2014-15. 4. The Odisha Judicial Service Main Written Examination, 2015 is scheduled to be held **from 02.11.2015 to 05.11.2015 at Bhubaneswar and Cuttack zones only**.

5. The eligible candidates are required to download their "Admission Certificates" and "Instructions to Candidates for OJS Main Examination, 2015" from the website of the Commission **from 26.10.2015** onwards and produce the same before the Centre Supervisor for admission to the Examination Centre.
